Enhancing Independent Community Pharmacist Involvement in NCPDP

Background and Objectives

- The primary purpose of the grant request is focused on the engagement of active and influential independent community pharmacists in the NCPDP standards-development process and less on research and method.
- Independent community pharmacies account for approximately one-third of all outpatient pharmacy
 locations in the U.S., however, they are underrepresented at the technical work group meetings of the
 National Council for Prescription Drug Programs (NCPDP). The result is a partial void for NCPDP in
 terms of losing a unique and important level of expertise. In addition, these independents lose an
 important opportunity for mutual understanding while working toward a common goal with other
 health care stakeholders.
- This project has helped to close this gap in NCPDP membership since 2012. The presence of
 community pharmacists at NCPDP Work Group meetings has the immediate impact of ensuring that all
 segments of pharmacy practice have a voice in the standards development process. Their perspective
 and input are critical to NCPDP and its work because the standards that are developed affect the
 working environment that pharmacists deal with daily.
